Dear Chairman Johnson,

In response to your request of June 23, 2015, we are providing information on the Denali Commission's process for responding to Freedom of Information Act (FOIA) requests and the involvement of non-career officials.

The FOIA officer for the Denali Commission is its general counsel. According to Denali Commission officials, when FOIA requests are received, they are first reviewed by the FOIA officer. After review, the request is submitted to the Chief Financial Officer, who sends it to commission staff to search for any and all documents related to the request. Once documents are gathered, the FOIA requestor is typically allowed to review documents in person and make copies as necessary.

The Denali Commission does not have any presidential appointees. The only non-career employee is the Federal Co-Chair, who is nominated by the President pro tempore of the Senate and the Speaker of the House of Representatives and is appointed by the Secretary of Commerce. To the best of the FOIA officer's knowledge, the Federal Co-Chair has not had involvement in the Denali Commission's FOIA process other than searching relevant documents, which has not resulted in an undue delay of a response to a FOIA request or withholding of documentation since January 1, 2007.
