Dear Mr. McIntosh:

Congratulations for making the decision of retiring, as I understand it, that will occur at the end of this month. We wish you the best in your future endeavors whatever they may be.

Please refer to your letter of September 7, 2007; and in particular, the third paragraph of the letter. Please allow me to respond to you in the following manner:

1. Request for May: As I understand it, this will be provided to you soon.
2. Estimated expenses incurred by AFN for June, July and August: While AFN incurred expenses, primarily on staff times, responding to your requests on detailed work plans during these months; AFN will not be requesting reimbursements for these expenses we incurred during these months at this time.

Insofar as fourth paragraph is concerned, please allow me to respond to you in the following fashion:

1. Staff Work Activities by staff names: I, the undersigned, Nelson N. Angapak, Sr., of Alaska Federation of Natives, will monitor the activities of the non-staff work on uploading of information to the AFN Website as well as the activities of NACA on its finalization of NACA product pursuant to the contract that existed between AFN and NACA at an earlier time. Gladys Charles will be responsible for the accounting activities of AFN during the months of September and October 2007.
2. Staff Costs by name: \$10,829.00; this is an estimate and because of the privacy statutes of this nation, we request that you accept this without name and cost breakdowns. AFN does not want to unknowingly violate this statute; and I think the Denali Commission must respect this.

3. Non-staff work by Company:
 - A. Kathleen Russell Consulting: Uploading Center for Excellence Information onto AFN Website.
 - B. Native American Contractors Association (NACA): See item number 3.
4. Non-staff Costs by Company Name:
 - A. Kathleen Russell Consulting: \$10,000.00 Contract plus travel: \$1,500.00
 - B. Native American Contractors Association (NACA): 0, NACA is finalizing the deliverable product they are producing for AFN pursuant to a contracted that existed between AFN and NACA at an earlier time.
5. Deliverables to be Produced:
 - A. Kathleen Russell Consulting: Uploaded Center for Excellence Information on AFN Website.
 - B. Native American Contractors Association: Finalized report entitled "Analysis of the Social and Economic Impact of the Native 8(a) Business Development Program" will be submitted to AFN by NACA; and AFN, in turn will submit five copies of this report to the Denali Commission.
6. Deliverable Time: October 31, 2007
7. Description of any other activities/costs for which reimbursement will be requested:
 - A. Printing of "Analysis of the Social and Economic Impact of the Native 8(a) Business Development Program": \$7,500.00; this project will be handled through an RFP, therefore, we cannot identify Non-staff work by a specific company, however, it will be a company whose bid is the lowest. This will be distributed to the organizations or companies who may request copies of this report.
 - B. Beyond this, AFN does not foresee any other requests for reimbursements on this award at this time.

In my humble opinion, this letter fulfills your request for more work plan details in your letter of September 7, 2007.
