Bartlett Regional Hospital would like to ask for a one-year extension for the Skagway radiology project funded by the Denali Commission. As mentioned in the previous quarterly reports, initial plans to remodel the existing radiology room were waylaid when tests for asbestos showed up positive. Since that time, plans to remodel a different area of the Dahl Memorial Clinic have been underway. We have been working with an engineering firm to ensure proper installation of the radiology equipment has been taken into consideration in the remodel design and with an architect who has drawn up plans for the remodel.

As specified by the City of Skagway, the project went out to a 30-day bid, of which we have just received the result. Unfortunately, only one bid was received, and this bid was \$66,000 over the architect's estimate. We feel the high bid and the lack of bidders is due to the short time constraint of having the project completed by December 31, 2004.

A one-year extension of this project would allow for a more competitive bid process, which we expect will bring the bids in line with the architect's estimate. We appreciate your consideration of the extension as we pursue the completion of this project in the most fiscally responsible manner possible. 
