RE: Addendum No. "F" to Project 0146-DC-2004-I29

This letter is written in accordance to the Financial Assistance Award for the project referenced above and the Memorandum of Understanding (MOU) between the Denali Commission (Commission) and the Alaska Native Tribal Health Consortium (ANTHC), dated September 2004. This is the sixth such Addendum letter issued by the Commission, but is expected that this format will be used in future correspondence to clarify and further describe the scope of work previously funded through the award.

The following is offered: The Denali Commission directs the ANTHC to award

- A total of \$308,538 to Maniilaq Association, via pass-through, to reimburse for the funding of the designs of primary care clinic facilities in the following communities: Buckland (\$75,119); Deering (\$69,829); Selawik (\$163,590)


