



A. INTRODUCTION

Throughout this Amendment these entities are referred to as follows:

Maniilaq Association	=	Maniilaq Association
Alaska Native Tribal Health Consortium	=	ANTHC
Division of Environmental Health and Engineering	=	DEHE
Denali Commission	=	Commission
Financial Assistance Sub-Award	=	FSA

On Aug. 24, 2001, ANTHC and the Maniilaq Association executed an FSA authorized by the Denali Commission to design and construct a new health clinic in Kiana, Alaska.

The project was funded with \$716,100 of Denali Commission funds via Denali Commission Financial Assistance Award Project No. 0019-DC-2001-II, Amendment No. 1, dated July 2001.

B. REVISION OF PROJECT FUNDING

This Amendment adds \$39,065 via Denali Commission Financial Assistance Award Project No. 220-06, Amendment No. 1, dated September 2006. These funds reimburse the cost of clinic design.

Project funding therefore totals \$755,165.

A revised cost estimate table is provided below.

TO: FOR THE RECORD

An environmental review, in accordance with the National Environmental Policy Act (NEPA) and the National Historic Preservation Act (NHPA), is required for this project based upon proposed Federal funding for this project. The Alaska Native Tribal Health Consortium (ANTHC) has considered all potential environmental concerns (specific and cumulative effects) associated with this phase of the project in consultation with applicable federal, state, and local authorities. This review is restricted to the action undertaken in the amendments. Specifically, the design of the health facilities project is eligible for additional funds to cover expenses already incurred by the Maniilaq Association. The scope of the project remains unchanged with Amendment No. 1.

The ANTHC will revisit the environmental review to determine if potential environmental concerns have been addressed if the scope of work changes in the future.
