**A. INTRODUCTION**

On July 11, 2003, ANTHC and the City of Saint Michael and executed a Financial Assistance Sub-Award for the provision of a new health clinic in the City of Saint Michael, Alaska.

This project is funded by the Denali Commission, per Financial Assistance Award Project Number 0015-DC-2000- I4E, dated August 2002, and Financial Assistance Award Project No. 0100-DC-2003-I13, dated July 2003.

The project has previously been amended as follows:

Amendment No. 1 to the FSA added \$257,500, for a total award of \$562,000. The additional funding was added to address costs related to interior rough-in plumbing and exterior completion.
