*Award Conditions to the Financial Assistance Award
Between the Denali Commission and the Arctic Slope Native Association
For Conceptual Design – Barrow Replacement Hospital
Award No. 181-05

1. Scope of Work

The Indian Health Service (IHS) has identified a new hospital in Barrow on a national prioritization list for Tribal health facility improvements. Arctic Slope Native Association, Ltd. (ASNA) currently operates the existing Barrow Hospital (Samuel Simmonds Memorial Hospital) and will operate the proposed new facility. The IHS currently owns the existing facility, and will continue to own the new facility.

The Commission is providing a total of \$4,000,000 to ASNA for Architectural and Engineering (A&E) design of the Barrow replacement hospital facility. This design shall be based on the approved Program of Requirements (POR) ASNA has received from IHS Headquarters.

The IHS has provided \$2,958,322 in FY05 for the purchase of land for the Barrow Hospital Replacement project. It is anticipated that a balance of those funds will be available for ASNA to use in concert with the funds provided by the Commission for A&E design. Upon signature of the 2005 Agreement for the Barrow Hospital Design between the IHS and ASNA Commission funds will be released. This agreement articulates the responsibilities of IHS and ASNA for the expenditure of the design funds.

The Commission anticipates that the following key activities will be achieved by ASNA:

- A/E Contract 6/15/05 – 7/31/05
- Concept Design 8/1/05 – 9/31/05
- Design Development 10/01/05 – 6/01/06
- Construction Documents 7/01/06 – 9/31/06

ASNA shall offer to the Commission the opportunity to participate in the selection process of the design firm (not the project management firm). Given available staff time, the Commission may or may not elect to participate in the selection.

It is understood by the Commission and ASNA that the IHS will be funding the construction of the new hospital and consequently the IHS must be a participant and subject matter reviewer of all work products produced with Commission funding. This understanding has been formalized through separate Agreement between ASNA, the Commission and the IHS. The Commission reserves the right to establish a project oversight committee through its Health Steering Committee, to serve as subject matter reviewers of all project work products if the IHS is unable to fulfill this role.

All Commission funding is intended for use for the scope of work identified in the Award document only. Any balance of funds remaining after the full scope of work has been completed will be returned to the Denali Commission.

2. Milestones

The following milestones are identified as the major steps to be completed as part of the project. "Planned" dates for the first milestone are included here. As part of each progress report, recipients shall update the progress toward meeting these milestones (see section 7, Reporting).

3. Award Performance Period

The Award performance period is July 1, 2005 through July 1, 2007. This is the period during which Award recipients can incur obligations or costs against this Award.

Funds for this award are provided by the Health Resources and Services Agency (HRSA). HRSA requires that all recipients expend funds in a timely manner. In keeping with that requirement, funds associated with this award must be expended in full per the award performance period listed above

4. Direct and Indirect Costs

5. Budget and Program Revisions

6. *Payments*

Payments under this Award will be made through the U.S. Department of Treasury's Automated Standard Application for Payment (ASAP) system. The ASAP system is the Commission's mechanism for requesting and delivering Federal funds to Award recipients. ASNA must be registered with the ASAP program in order to make draw downs. Payments shall be made in accordance with OMB Circular A-110. **No interest will be accrued on these funds.**

7. *Reporting*

Two forms of project reporting are required under this Award, listed below. ASNA shall submit reports using the Denali Commission's on-line Project Database System, available at www.denali.gov. If there are technical limitations which may prevent the recipient from meeting this requirement, please contact the Program Manager listed in this agreement.

- a. **Progress Reports** shall be submitted on a quarterly basis. The first reporting period is July 1, 2005 through September 30, 2005, and each quarter thereafter. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
 - i. Total project funding, including both Denali Commission funding and other project funding sources.
 - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and Other funding sources.
 - iii. Update schedule and milestone information as identified in the Scope of Work
 - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
 - v. For minor repair and renovation projects or other non-construction projects, pictures should be provided of before and after, or photos that are representative of the funded activity, to the extent possible. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
- b. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200] "Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part [subpart 205]. The determination of when an award is expended should be based on when the activity related to the award occurs."

8. Award Close-Out

The award close-out shall be completed within 90 days of the end of the Award performance period or within 90 days of the completion of the project, whichever is earlier. Recipients must also draw down any remaining funds for expenditures incurred under this award during this 90-day period.

The Award Close-out report shall be submitted on-line through the Denali Commission's on-line Project Database System, available at www.denali.gov. The project close out will require the recipient to submit the following information:

- a. Final data for each item listed in paragraph 7(a) "Progress Reports"
- b. Final project expenditures itemized by the following categories: planning & design; materials & equipment; freight; labor; project administration/overhead and other expenses.
- c. Acknowledgement of support: For all non-construction projects, the Award recipient shall include an acknowledgement of the Government's support for the project(s) developed under this Award. The format for acknowledgement of the Government's support for non-construction awards will vary with each award and must be agreed upon between the Award recipient and the Denali Commission Project Manager. Costs associated with this requirement shall be paid out of the project funding received by the Award recipient from the Denali Commission.

9. Public Policy Laws and Assurances

Award Recipients are required to comply with the public policy laws and assurances on Standard Forms SF 424b (non-construction projects) or SF 424d (construction projects). This form must also be signed by a certifying official of the organization. Some of the laws are highlighted below for your reference.

To the maximum extent practicable, considering applicable laws, Funding Recipients shall accomplish the project contemplated by the Award using local Alaska firms and labor.

Project level environmental reviews in accordance with the National Environmental Policy Act (NEPA) and the National Historic Preservation Act (NHPA) are required for each project undertaken with Denali Commission funds.

10. Non-Compliance with Award Conditions

Recipients not in compliance with the terms and conditions of this Financial Assistance Award will be notified by the Denali Commission. The Denali Commission will work with the recipient to identify the steps necessary to bring them back into compliance, and will establish an appropriate time frame for the corrections to be made. If the corrections have not been made by the deadline, the Denali Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
