All changes to the award conditions are noted below.

1. Scope of Work

This Award is amended to include funds for the acquisition of materials and the construction of a gated, 700 LF fence (\$35,000) for the Takotna landfill. The fence will contain blowing trash and limit the access of animals into the active area of the landfill. Further, it will increase public safety and encourage the appropriate disposal of waste by the community. The Takotna Tribal Council will commit \$8,000 in engineering and in-kind services to the project.

The title of this award is also amended to recognize this addition to the scope.

There are no other changes to the original Financial Assistance Award.


