

***Award Conditions to the Financial Assistance Award  
Between the Denali Commission and City of Buckland  
For Washeteria Renovation and Repairs  
Award No. 164-05, Amendment 2  
July 2005***

All changes to the award conditions are noted below.

***1. Scope of Work***

The level of fire protection for the Buckland washeteria is amended to remove the requirement of a residential sprinkler system. The use of interior construction elements as described to the Fire Marshall (including a painted concrete floor, sheet rock fire barrier ceiling, and "FRP" flame-spread resistant fiberglass wall panels) is deemed sufficient and appropriate protection for this facility. This amendment deobligates \$38,300 from the original award.

***2. Award Performance Period***

The Award performance period remains February 1, 2005 through December 31, 2005. This is the period during which Award recipients can incur obligations or costs against this Award.

There are no other changes to the original Financial Assistance Award, as amended.
