

All changes to the award conditions are noted below.

***1. Scope of Work***

This amendment deobligates \$2,470.40, from the Cordova Community Medical Center project funded under this award. The project closed out under budget; funds will be reobligated to primary care clinic activities.

This amendment also deobligates \$84.00 from the Fairbanks Diabetes Self Management Center Equipment Purchase project funded under this award. The project closed out under budget; funds will be reobligated to primary care clinic activities.

Total funding deobligated from this award under this Amendment is \$2,554.40.

Please note that Amendment 3 to this award had an error in the "Funding from Prior Periods" cell for Denali Commission Funding and therefore gave an erroneous total. This cell should have read \$3,650,000 instead of \$3,583,000. The total Denali Commission funding after Amendment 3 was \$3,582,700. Total Denali Commission funding remaining on this award after Amendment 4 is \$3,580,145.60.
