All changes to the award conditions are noted below.

***1. Direct and Indirect Costs***

The following changes are made to Direct and Indirect Budget Costs under this award:

- The Denali Training Fund Balance Available to applicants is decreased by \$10,000 for a new budget of \$1,925,000.
- The DOL Program Budget is increased by \$10,000 for a new budget of \$75,000. DOL is allowed to pay for Administration Costs from this budget line item.

There are no other changes to the original Financial Assistance Award, as amended.
