***Award Conditions to the Financial Assistance Award

All changes to the award conditions are noted below.

***1. Scope of Work***

This scope of work includes an increase in funding of \$663,768.06 to the power plant upgrade projects within this award (project No. 380329-2000--Aniak, Chuathbaluk, Crooked Creek, Red Devil, Sleetmute, Takotna, Stony River, Middle Kuskokwim Regional Energy Project, RPSU Construction). There are no changes to the scope of work for this project.

***2. Award Performance Period***

The Award performance period is not changed by this amendment, and remains December 1, 2004 through June 30, 2007. This is the period during which Award recipients can incur obligations or costs against this Award. Due to the nature of this funding completion award, costs incurred prior to December 8, 2004 for elements which have been carried forward from a previous award are allowable under this award.

There are no other changes to the original Financial Assistance Award, as amended.
