All changes to the award conditions are noted below.

***1. Scope of Work***

This amendment adds no additional funding to the award. This amendment establishes a pool for unallocated funds within the award and provides authorization to proceed with an award to the Tundra Women's Coalition Bethel Domestic Violence project in the amount up to \$300,000 for planning and design.

That addition to scope reads as follows:

**06-4-C-5031: Tundra Women's Coalition (Bethel) – up to \$300,000**

This project has completed a business plan and is ready for design. Construction funds for this project are not yet authorized. Previous expenditures such as site preparation and fees associated with site acquisition are allowable upon program manager approval. A competitive Request For Proposal (RFP) for the design contract will be conducted and shall be approved by the program manager prior to solicitation and execution.

**0136-DV-POOL: Statewide Pool Domestic Violence Facilities -- \$195,000**

After the above adjustments, a statewide pool shall be established as a subproject to this award in the amount of \$195,000. This documents the existing unallocated funds for domestic violence in this award. Future domestic violence funding authorizations shall be deducted from the statewide pool.

***2. Award Performance Period***

There are no changes to the performance period.
