



**1. Scope of Work**

**Transfer permitting, design, construction and ownership of the Juneau/Greens Creek/Hoonah Intertie to the newly formed Intertie Cooperative, KWETICO.**

**Complete permitting and design** of the JGCHI between North Douglas and Hawk Inlet and the Greens Creek Mine. This is part of the overall JGCHI that will connect the Greens Creek Mine and Hoonah, Alaska to Alaska Electric Light & Power Company's (AELP) power grid and the planned Lake Dorothy Hydroelectric Project. When completed the JGCHI, will consist of a total of 63.5 mile of transmission line: 34 miles of the transmission line will be submarine cable and 29.5 miles will be overhead transmission line.

**Begin construction** of the remaining 52.5 miles of the JGCHI. Phase 2 of the intertie will cost \$15 million and extend from north Douglas Island to Greens Creek on Admiralty Island. Phase 3, the final phase, will cost \$20 million and go from Greens Creek on Admiralty Island to Hoonah. If additional funding is provided, both Phases 2 and 3 could be built in 2004-2005.

All Commission funding is intended for use for the scope of work identified in the Award document only. In the event there is a balance of funding remaining after the full scope of work has been completed, the Denali Commission shall determine how the excess funds will be allocated.

**2. Milestones**

The following milestones are identified as the major steps to be completed as part of the project. "Planned" dates for the first milestone are included here. As part of each progress report, recipients shall update the progress toward meeting these milestones (see section 7, Reporting).

**3. Award Performance Period**

The Award performance period is July 1, 2004 through December 31, 2006. This is the period during which Award recipients can incur obligations or costs against this Award. All reimbursable expenses incurred prior to July 1, 2004 have been attributed to AELP

under project #0115-DC-2004-I3. Matching funds in the amount of \$2,118,937.00 have also been attributed to AELP under that project.

#### ***4. Direct and Indirect Costs***

The cost principles of OMB A-122 are applicable to this Award. The direct cost of KWETICO personnel time devoted to the performance of the award, are allowable. Indirect costs up to 5% of direct costs are allowable under this Award, and are included in the amount of the award. AELP, as a principle subcontractor to KWETICO has established the following rates, which are included in the amount of the award. Fringe benefits as follows are allowable under this Award and are included in the amount of the award. For 2004: Clerical fringe benefits of 72.45% of direct labor for straight time and 7.98% of direct labor for overtime; Engineer fringe benefits of 36.76% of direct labor and 19% of direct labor for vehicle usage. For 2005 and 2006: Not yet determined. The fringe benefit and vehicle usage percentages applied to direct labor are in lieu of directly charging these items, and are not duplicated in the allocation of indirect costs. The fringe benefit and vehicle usage percentages applied to direct labor are estimates of actual costs, but a true up between estimated and actual costs will not be made to this project. There are no profit markups for work performed by AELP's workforce on this project. Please refer to the cost principles regulations for specific details on other allowable charges under this Award

#### ***5. Budget and Program Revisions***

  - i. Total project funding, including both Denali Commission funding and other project funding sources.
  - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and Other funding sources.
  - iii. Update schedule and milestone information as identified in the Scope of Work
  - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
  - v. Photographic documentation of project progress shall be provided with the progress reports for active construction projects. The photo documentation shall include a minimum of three, dated photos per reporting period such that a complete record of the construction is maintained over time, from "before," showing the situation before the start of construction, to "during" showing work proceeding on the project, and "after" to show the finished project. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
  
- b. **Wage and Residency Reports** shall be submitted on an annual basis using the Denali Commission On-line Project Database. The reporting period is January 1<sup>st</sup> – December 31<sup>st</sup> of each year. Reports are due within 30 days of the end of the reporting period. The Wage and Residency Report shall include the following information by for each construction project
  - i. Total number of Local Residents employed during the year and their total payroll earnings.
  - ii. Total number of Non-Local Alaska Residents employed during the year and their total payroll earnings.
  - iii. Total number of Non-Alaska Residents employed during the year and their total payroll earnings.
  
- c. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200] "Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part. - b. Final project expenditures itemized by the following categories: planning & design; materials & equipment; freight; labor; project administration/overhead and other expenses.
- c. Acknowledgement of support: For all construction projects, the Award recipient shall display a sign that acknowledges the Government's support for the project(s) developed under this Award. The Commission will provide an appropriate sign. The Award recipient must request an indoor and/or an outdoor sign from the Commission office. Pickup or delivery of the sign can be arranged at that time.

If the corrections have not been made by the deadline, the Denali Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
