Between the Denali Commission and Naknek Electric Association, Inc.,
For Technical and Management Assistance to Rural Electric Utility Systems

All changes to the award conditions are noted below.

1. Scope of Work

The original scope of work is not changed by this amendment, however, the term of the management assistance agreement and the payment allocation schedule is revised to reflect the as-built time line for the new power plant. The power plant was initially planned to be completed by December of 2004, while in fact it was completed in September 2006. Now that the power plant is operational, the payment allocation requires that Manokotak Electric beginning sharing the cost of the technical and management support provided by Naknek Electric Association.

2. Award Performance Period

The amended Award performance period is April 15, 2004 through November 30, 2008. This is the period during which Award recipients can incur obligations or costs against this Award.

There are no other changes to the original Financial Assistance Award, as amended.
