

***Award Conditions to the Financial Assistance Award  
Between the Denali Commission and  
City of Cordova for Cordova Dust Control with Asphalt Surfacing  
Award No. 292-07  
May 2007***

***1. Scope of Work***

This project involves chip sealing of approximately 23,800 feet of roads and streets within the incorporated area of the City of Cordova over a two-year period. The surface treatment will be applied to a width of 24 feet. The majority of roads to receive this treatment serve residential populations. The primary goal is elimination of dust from vehicle travel on gravel roads/streets, a known health hazard. Additional project benefits include a major reduction in the cost of road maintenance and reduced erosion into adjacent rivers and lake, which negatively affects important salmon habitat. A double layer of chip seal should provide a durable surface and dust free environment for a period of 5-8 years. As the end of the surface treatment's useful life approaches, a single maintenance layer of chip seal should bring the treated surface back to its original condition.

All Denali Commission funding is intended for use within the scope of work identified in the Award document only. Any balance of funds remaining after the full scope of work has been completed will be returned to the Denali Commission.

***2. Milestones***

The following milestones are identified as the major steps to be completed as part of the project. "Planned" dates for the first milestone are included here. As part of each progress report, City of Cordova reporting systems will update the progress toward meeting these milestones (see section 7, Reporting).

***3. Award Performance Period***

The Award performance period is April 1, 2007 through March 31, 2009. This is the period during which Award recipients can incur obligations or costs against this Award.

#### **4. Direct and Indirect Costs**

Direct costs associated with the Cordova Dust Control with Asphalt Surfacing project are allowed under this document. Indirect costs associated with City of Cordova management of Denali Commission funds are allowed at the rate established by City of Cordova at 3.87% for 2006 and approved by FHWA for Title 23 funds.

#### **5. Budget and Program Revisions**

The Uniform Administrative Requirements, OMB A-102, apply to this Award. Please refer to this circular for specific details on revisions to this Award. The circular requires City of Cordova to inform the Denali Commission in writing at the earliest possible date of any unanticipated project cost overrun, project schedule delays, or changes in the project scope or changed site conditions. The City of Cordova is responsible for cost overruns on this project.

#### **6. Payments**

Payments under this Award will be made by electronic transfer in response to a "Request for Advance or Reimbursement", Standard Form 270 (SF-270) submitted by City of Cordova. Requests for advances or reimbursements may be made at the end of each quarter and should be submitted no later than 30 days after the federal quarter. #### **7. Reporting**

Three forms of project reporting are required under this Award, listed below. The City of Cordova shall submit reports using the Denali Commission's on-line Project Database System, available at [www.denali.gov](http://www.denali.gov). If there are technical limitations which may prevent the recipient from meeting this requirement, please contact the Program Manager listed in this agreement.

- a. **Progress Reports** shall be submitted on a quarterly basis. The first reporting period is April 1, 2007 through June 30, 2007 and quarterly thereafter. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
  - i. Total project funding, including both Denali Commission funding and other project funding sources.
  - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and other funding sources.

- iii. Updated schedule and milestone information as identified in the Scope of Work
  - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
  - v. Photographic documentation of project progress shall be provided with the progress reports for active construction projects. The photo documentation shall include a minimum of three, dated photos during the construction period such that a complete record of the construction is maintained over time, from “before,” showing the situation before the start of construction, to “during” showing work proceeding on the project, and “after” to show the finished project. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
- b. **Wage and Residency Reports** shall be submitted on an annual basis using the Denali Commission On-line Project Database. The reporting period is January 1<sup>st</sup> – December 31<sup>st</sup> of each year. Reports are due within 30 days of the end of the reporting period. The Wage and Residency Report shall include the following information for each construction project
- i. Total number of Local Residents employed during the year and their total payroll earnings.
  - ii. Total number of Non-Local Alaska Residents employed during the year and their total payroll earnings.
  - iii. Total number of Non-Alaska Residents employed during the year and their total payroll earnings.
- c. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200] “Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part [subpart 205]. The determination of when an award is expended should be based on when the activity related to the award occurs.”

## **8. Project/Award Close-Out**

The project close-out report shall be completed within 90 days of the end of the Award performance period or within 90 days of the completion of the project, whichever is earlier. - c. Acknowledgement of support: For all construction projects, the Award recipient shall display a sign that acknowledges the Government's support for the project(s) developed under this Award. The Commission will provide an appropriate sign. The Award recipient must request an indoor and/or an outdoor sign from Denali Commission. Pickup or delivery of the sign can be arranged at that time.

#### ***9. Public Policy Laws and Assurances***

Award Recipients are required to comply with the public policy laws and assurances on Standard Forms SF 424d (construction projects). This form must also be signed by a certifying official of the organization. Some of the laws are highlighted below for your reference.

Recipients not in compliance with the terms and conditions of this Financial Assistance Award will be notified by the Denali Commission. The Denali Commission will work with the recipient to identify the steps necessary to bring them back into compliance, and will establish an appropriate time frame for the corrections to be made. If the corrections have not been made by the deadline, the Denali Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
