1. Scope of Work

This effort will be undertaken by the Upper Copper Valley Community Development Corporation, a subsidiary of Mt. Sanford Tribal Consortium (MSTC), given the economic development components of this project. MSTC provides health, environmental and social services from two separate clinics located in Mentasta Lake and Chistochina.

MSTC intends to issue a contract to produce a comprehensive community/regional plan to determine future health services and identify economic strategies for the region. It is understood that MSTC is presently collaborating with Crossroads Medical Center, Copper River Native Association and Chitina Village Council on a regional health strategy for the region. These two separate (but similar) efforts must be coordinated by MSTC to effectively produce successful work products for both.

Likewise, MSTC is interested in developing economic opportunities for its Tribal members. Development of such opportunities must be based upon sustainable services and facilities and it is expected that the comprehensive community plan will feed both development of clinic business plans and pro-forma/business plans for economic strategies. The end result of the health analysis and economic development strategies is development of multi-use facilities that may house these function or the separation of these functions into separate structures. The parties will consider this project a success when at the end MSTC has a clear direction on whether to co-locate their programs into individual structures or to offer only health services in the clinics.

MSTC shall use competitive procurement procedures and shall conduct a full and open competition to select the contractor for this effort.

All Commission funding is intended for use for the scope of work identified in the Award document only. In the event there is a balance of funding remaining after the full scope of work has been completed, the Denali Commission shall determine how the excess funds will be allocated.

2. Milestones

The following milestones are identified as the major steps to be completed as part of the project. "Planned" dates for the first milestone are included here. As part of each progress report, recipients shall update the progress toward meeting these milestones (see section 7, Reporting).

3. Award Performance Period

The Award performance period is October 1, 2004 through September 30, 2006. This is the period during which Award recipients can incur obligations or costs against this Award.

4. Direct and Indirect Costs

The ASAP system is the Commission's mechanism for requesting and delivering Federal funds to Award recipients. MSTC must be registered with the ASAP program in order to make draw downs. Payments shall be made in accordance with Administrative Circular A-110.

7. Reporting

Two forms of project reporting are required under this Award, listed below. MSTC shall submit reports using the Denali Commission's on-line Project Database System, available at www.denali.gov. If there are technical limitations which may prevent the recipient

from meeting this requirement, please contact the Program Manager listed in this agreement.

- a. **Progress Reports** shall be submitted on an quarterly basis. The first reporting period is October 1, 2004 to December 31, 2004, and each quarter thereafter. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
 - i. Total project funding, including both Denali Commission funding and other project funding sources.
 - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and Other funding sources.
 - iii. Update schedule and milestone information as identified in the Scope of Work
 - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
 - v. For minor repair and renovation projects or other non-construction projects, pictures should be provided of before and after, or photos that are representative of the funded activity, to the extent possible. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
 - vi. **Wage and Residency Reports** are not required for this Award.
- b. **Federal Single Audits** shall be submitted annually, when required. 8. Project Close-Out

- c. Acknowledgement of support: For all non-construction projects, the Award recipient shall include an acknowledgement of the Government's support for the project(s) developed under this Award. The format for acknowledgement of the Government's support for non-construction awards will vary with each award and must be agreed upon between the Award recipient and the Denali Commission Project Manager. Costs associated with this requirement shall be paid out of the project funding received by the Award recipient from the Denali Commission.

9. Public Policy Laws and Assurances

Award Recipients are required to comply with the public policy laws and assurances on Standard Forms SF 424b (non-construction projects) or SF 424d (construction projects). This form must also be signed by a certifying official of the organization. Some of the laws are highlighted below for your reference.

10. Non-Compliance with Award Conditions

Recipients not in compliance with the terms and conditions of this Financial Assistance Award will be notified by the Denali Commission. The Denali Commission will work with the recipient to identify the steps necessary to bring them back into compliance, and will establish an appropriate time frame for the corrections to be made. If the corrections have not been made by the deadline, the Denali Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
