**1. *Scope of Work***

The project consists of preliminary engineering work for new construction of a barge landing, boat harbor, upland support facilities, airport and interconnecting roadway. The goal of this phase of the project is to collect the data to determine its feasibility and complete up to 30% of final design. The project is aimed at providing basic transportation services to one of the most remote inhabited locations in the country. Basic transportation services are beneficial to the health and economic welfare of the community. In particular, Norton Sound Economic Development Corporation will be conducting an assessment of a subsistence and commercial fishery based in the Little Diomedes Harbor and using the proposed airport to reach potential markets.

All Denali Commission funding is intended for use within the scope of work identified in the Award document only. Any balance of funds remaining after the full scope of work has been completed will be returned to the Denali Commission.

**2. *Milestones***

The following milestones are identified as the major steps to be completed as part of the project. "Planned" dates for the first milestone are included here. As part of each progress report, Kawerak, Inc. reporting systems will update the progress toward meeting these milestones (see section 7, Reporting).

**3. *Award Performance Period***

#### **4. Direct and Indirect Costs**

Direct costs associated with the Diomedede Harbor/ Barge Landing Preliminary Engineering project are allowed under this document. Indirect costs associated with Kawerak, Inc. management of Denali Commission funds are allowed at the rate established by Kawerak, Inc. at 3.87% for 2006 and approved by FHWA for Title 23 funds.

#### **5. Budget and Program Revisions**

#### **7. Reporting**

Three forms of project reporting are required under this Award, listed below. Kawerak, Inc. shall submit reports using the Denali Commission's on-line Project Database System, available at [www.denali.gov](http://www.denali.gov). If there are technical limitations which may prevent the recipient from meeting this requirement, please contact the Program Manager listed in this agreement.

- a. **Progress Reports** shall be submitted on a quarterly basis. The first reporting period is April 1, 2007 through June 30, 2007 and quarterly thereafter. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
  - i. Total project funding, including both Denali Commission funding and other project funding sources.
  - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and other funding sources.

- iii. Updated schedule and milestone information as identified in the Scope of Work
  - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
  - v. Photographic documentation of project progress shall be provided with the progress reports for active construction projects. The photo documentation shall include a minimum of three, dated photos during the construction period such that a complete record of the construction is maintained over time, from “before,” showing the situation before the start of construction, to “during” showing work proceeding on the project, and “after” to show the finished project. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
- b. **Wage and Residency Reports** shall be submitted on an annual basis using the Denali Commission On-line Project Database. The reporting period is January 1<sup>st</sup> – December 31<sup>st</sup> of each year. Reports are due within 30 days of the end of the reporting period. The Wage and Residency Report shall include the following information for each construction project
- i. Total number of Local Residents employed during the year and their total payroll earnings.
  - ii. Total number of Non-Local Alaska Residents employed during the year and their total payroll earnings.
  - iii. Total number of Non-Alaska Residents employed during the year and their total payroll earnings.
- c. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200] “Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part [subpart 205]. The determination of when an award is expended should be based on when the activity related to the award occurs.”

#### **8. Project/Award Close-Out**

The Commission will provide an appropriate sign. The Award recipient must request an indoor and/or an outdoor sign from Denali Commission. Pickup or delivery of the sign can be arranged at that time.

#### ***9. Public Policy Laws and Assurances***
