***Award Conditions to the Financial Assistance Award
Between the Denali Commission &
The AVCP Regional Housing Authority
For a Teacher Housing Repair and Renovation Pilot Program-
Yukon Kuskokwim Delta Region***

Project No. 149-DC-2005

1. Scope of Work

The AVCP Regional Housing Authority will undertake repair and renovations on existing teacher housing in the Yukon Kuskokwim Delta Region that have been identified in the high needs category of a statewide teacher housing assessment. The AVCP Regional Housing Authority will solicit repair/renovation requests from targeted school districts and make project selections through their in-house review process. Listed below is a target schedule for this project.

Timeline

December 17, 2004	School districts must submit a scope of work for renovation requests.
December 31, 2004	The AVCP Regional Housing Authority will contact school districts with sites that have been selected.
January 7, 2005	Full application is due from school districts.
Fall 2005	<u>Interior</u> repair / renovation work must be completed by the beginning of the new school year. <u>Exterior</u> work that does not prevent teachers from living inside the unit shall be allowed through November 30, 2005.

The scope of work, cost estimates, and timelines will be agreed upon, in writing, by the school district and AVCP Regional Housing Authority.

The Denali Commission will provide up to fifty percent (50%) of the total repair and renovation cost. The school district is responsible for the remaining fifty percent (50%). The school district funding match must be deposited with AVCP Regional Housing Authority before work will commence. While it is presumed that AVCP Regional Housing Authority will do most of the repair and renovation work, the Housing Authority does have the authority to enter into sub-grantee relationships with the school district to do minor repair / renovation work if the school district prefers this approach.

Renovation projects should not be proposed if the cost exceeds 40% (or \$110/sq) of the cost of new teacher housing construction. NANA Pacific has completed a statewide cost containment analysis on teacher housing projects. The analysis indicates that \$259/sq ft. would be the new construction benchmark for the YK Delta. AVCP Regional Housing Authority should use benchmark costs developed by NANA Pacific to estimate new

construction costs. The report is posted on the Denali Commission website under Resources. A hard copy of the report will be provided to AVCP Regional Housing Authority for use during this pilot program.

All Commission funding is intended for use for the scope of work identified in the Award document only. In the event there is a balance of funding remaining after the full scope of work has been completed, the Denali Commission shall determine how the excess funds will be allocated.

2. Milestones

As there are multiple sub-projects, appropriate milestones will be identified specifically for each sub-project, when the database record is created by AVCP Housing Authority in accordance to Section 7, Reporting. An example of minimum project milestone reporting is shown below.

3. Award Performance Period

The Award performance period is 12/01/04 through 12/31/05. This is the period during which Award recipients can incur obligations or costs against this Award.

4. Direct and Indirect Costs

The cost principles of OMB A-122 are applicable to this Award. Indirect costs up to 1% are allowable under this Award. Please refer to the cost principles regulations for specific details on other allowable charges under this Award.

5. Budget and Program Revisions

The Administrative Circular A-110 applies to this Award. Please refer to the Administrative Circular for specific details on revisions to this Award. The Administrative Circular requires that AVCP Regional Housing Authority will inform the Commission in writing (e-mail, letter, or report) at the earliest possible date of any unanticipated project cost overrun, project schedule delays, or changes in the project scope or changed site conditions.

6. *Payments*

Payments under this Award will be made through the U.S. Department of Treasury's Automated Standard Application for Payment (ASAP) system. The ASAP system is the Commission's mechanism for requesting and delivering Federal funds to Award recipients. Your organization must be registered with the ASAP program in order to make draw downs. Please contact the Commission's Program Manager or Finance Manager for further information about registering with the ASAP program. Payments shall be made in accordance with OMB A-122. **No interest will be accrued on these funds.**

7. *Reporting*

Three forms of project reporting are required under this Award, listed below. AVCP Regional Housing Authority shall submit reports using the Denali Commission's on-line Project Database System, available at www.denali.gov. If there are technical limitations which may prevent the recipient from meeting this requirement, please contact the Program Manager listed in this agreement.

- a. **Progress Reports** shall be submitted quarterly. The first reporting period is December 1, 2004 to March 31, 2005, and every ninety (90) days thereafter. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
 - i. Total project funding, including both Denali Commission funding and other project funding sources.
 - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and Other funding sources.
 - iii. Update schedule and milestone information as identified in the Scope of Work
 - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
 - v. **Construction Projects** Photographic documentation of project progress shall be provided with the progress reports for active construction projects. The photo documentation shall include a minimum of three, dated photos per reporting period such that a complete record of the construction is maintained over time, from "before," showing the situation before the start of construction, to "during" showing work proceeding on the project, and "after" to show the finished project. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
- b. **Wage and Residency Reports** shall be submitted on an annual basis using the Denali Commission On-line Project Database. The reporting period is January 1st – December 31st of each year. Reports are due within 30 days of the end of the

- reporting period. The Wage and Residency Report shall include the following information by for each construction project
- i. Total number of Local Residents employed during the year, and their total payroll earnings.
 - ii. Total number of Non-Local Alaska Residents employed during the year, and their total payroll earnings.
 - iii. Total number of Non-Alaska Residents employed during the year, and their total payroll earnings.
- c. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200] “Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part. [subpart 205] The determination of when an award is expended should be based on when the activity related to the award occurs.”

8. Project Close-Out

The project close-out shall be completed within 90 days of the end of the Award performance period or within 90 days of the completion of the project, whichever is earlier. Recipients must also draw down any remaining funds for expenditures incurred under this award during this 90-day period.

The Project Close-out report shall be submitted on-line through the Denali Commission’s on-line Project Database System, available at www.denali.gov. The project close out will require the recipient to submit the following information:

- a. Final data for each item listed in paragraph 6(a) “Progress Reports”
- b. Final project expenditures itemized by the following categories: planning & design; materials & equipment; freight; labor; project administration/overhead and other expenses.
- c. Acknowledgement of support: For all construction projects, the Award recipient shall display a sign that acknowledges the Government’s support for the project(s) developed under this Award. The Commission will provide an appropriate sign. The Award recipient must request an indoor and/or an outdoor sign from the Commission office. Pickup or delivery of the sign can be arranged at that time.

9. Public Policy Laws and Assurances

Award Recipients are required to comply with the public policy laws and assurances on Standard Forms SF 424b (non-construction projects) or SF 424d (construction projects).

This form must also be signed by a certifying official of the organization. Some of the laws are highlighted below for your reference.

To the maximum extent practicable, considering applicable laws, Funding Recipients shall accomplish the project contemplated by the Award using local Alaska firms and labor.

No portion of this award may be used for lobbying or propaganda purposes as prohibited by 18 U.S.C. Section 1913 or Section 607(a) of Public Law 96-74.

Project level environmental reviews in accordance with the National Environmental Policy Act (NEPA) and the National Historic Preservation Act (NHPA) are required for each project undertaken with Denali Commission funds.

9. *Non-Compliance with Award Conditions*

Recipients not in compliance with the terms and conditions of this Financial Assistance Award will be notified by the Denali Commission. The Denali Commission will work with the recipient to identify the steps necessary to bring them back into compliance, and will establish an appropriate time frame for the corrections to be made. If the corrections have not been made by the deadline, the Denali Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
