



***1. Scope of Work***

Funding in the amount of \$5,368,400 is provided by the Denali Commission to the Department of Health and Social Services (DHSS) for statewide youth psychiatric facilities and DHSS grant management fees. Construction and/or renovation projects are funded in the amount of \$5,063,000 and are detailed in Table "A". These projects have completed all due diligence and are ready to proceed with grant funding, with conditions applied to the Alaska Family Baptist Services and Southcentral Foundation projects as noted. Management fees in the amount of \$305,400 are provided to cover costs of ongoing grants management of all Commission funded health projects under the DHSS through June 30, 2010.

All Commission funding is intended for use for the scope of work identified in the Award document only. Any balance of funds remaining after the full scope of work has been completed will be returned to the Denali Commission.

\*Alaska Family Baptist Services is conditionally approved for design funding in the amount of \$221,159 pending business plan approval. If this project does not proceed in a timely manner, this funding may be reallocated to other projects with priority given to the Southcentral Foundation project in Eklutna.

\*\* Southcentral Foundation (SCF) was approved for \$3,500,000 total construction funding in the FY07 health strategy, however \$3,098,760 will be provided in this award and the balance shall be funded w/prior year funds through a separate award action. Prior year funds shall be expended first. Construction is scheduled to proceed in spring 2007, and a final written scope of work with accompanying budget must be submitted and approved by the Denali Commission to be considered an allowable expense under this award.

Note: All sub-recipient grantees will be required to adhere to the requirements set forth in the grant award executed between the grantee and the State of Alaska. The following are the requirements for a Deed of Trust securing the States and the Federal government's interest. The Denali Commission recognizes these requirements as applicable to the projects funded through this award.

A. The GRANTEE shall promptly notify the DEPARTMENT in writing if at any time within twenty (20) years after completion of the project if either:

1. the GRANTEE organization ceases to exist, or operation of the FACILITY is considered for transfer to another agency, organization, person or persons; or
2. the FACILITY ceases to be operated for a public purpose, or cease to serve the purpose, as stated at the time of this grant.

If either of the conditions set out in "A" above occurs the DEPARTMENT is entitled to recover from the GRANTEE an amount which reflects the same ratio to the then value of the facility as the amount available under this grant agreement relates to the initial cost of the facility, unless the Commissioner of the Department of Health & Social Services determines there is good cause for releasing the GRANTEE from its obligations under this agreement. The value of the facility at the time of recovery under this section shall be determined by agreement between the DEPARTMENT and the GRANTEE or its successor, or by action taken in an appropriate court.

The Department's rights to recovery as specified above, shall be secured by means of a fully executed, and recorded, Deed of Trust or other appropriate security agreement. This security agreement must be in place prior to the close out and final disbursement of funds under this grant agreement.

The cost principles of OMB Circular A-87 are applicable to this Award. There are no indirect costs eligible to A-DHSS under this Award. Please refer to the cost principles regulations for specific details on other allowable charges under this Award.

**5. Budget and Program Revisions**

The Administrative Circular, OMB A-102, applies to this Award. Please refer to the Administrative Circular for specific details on revisions to this Award. The Administrative Circular requires that A-DHSS will inform the Commission in writing (e-mail, letter, or report) at the earliest possible date of any unanticipated project cost overrun, project schedule delays, or changes in the project scope or changed site conditions.

With each sub-award, A-DHSS shall document a project cash flow timeline for both Commission and contributor funding. In general, the Commission supports utilizing all of the Commission funding up front if the applicants contributions are loans. However, if the applicant's contributions are from grants or their own cash reserves, the cash flow shall be equally distributed between the various funding sources.

**6. Payments**

Payments under this Award will be made through the U.S. Department of Treasury's Automated Standard Application for Payment (ASAP) system. ## **7. Reporting**

Three forms of project reporting are required under this Award, listed below. A-DHSS shall submit reports using the Denali Commission's on-line Project Database System, available at [www.denali.gov](http://www.denali.gov). If there are technical limitations which may prevent the recipient from meeting this requirement, please contact the Program Manager listed in this agreement.

- a. **Progress Reports** shall be submitted on a quarterly basis. The first reporting period is August 1, 2007 to September 30, 2007 and quarterly thereafter. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
  - i. Total project funding, including both Denali Commission funding and other project funding sources.
  - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and Other funding sources.
  - iii. Updated schedule and milestone information as identified in the Scope of Work
  - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
  - v. **Construction Projects** Photographic documentation of project progress shall be provided with the progress reports for active construction projects. The photo documentation shall include a minimum of three, dated photos per reporting period such that a complete record of the construction is maintained over time, from "before," showing the situation before the start of construction, to "during" showing work proceeding on the project, and "after" to show the finished project. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
  - vi. **Non-Construction Projects** For minor repair and renovation projects or other non-construction projects, pictures should be provided of before and after, or photos that are representative of the funded activity, to the extent possible. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
- b. **Standard Form 269A Financial Status Report – Short Form (SF269A)** shall be submitted on a quarterly basis via fax, e-mail or mail. As with the Progress Reports, the SF269A is due within 30 days of the end of the quarter and a final SF269A is due within 90 days of the end of the Award Performance Period. Please note the following:

- i. This report cannot yet be submitted through the Denali Commission On-line Project Database and therefore must be submitted via fax, e-mail or mail.

However, the completed SF269A must be printed and signed, and then the completed SF269A must be submitted to the Denali Commission via mail, fax or as a PDF attachment to an e-mail to [finance@denali.gov](mailto:finance@denali.gov).
  - iv. If you have multiple projects under a single Financial Assistance Award, the SF269A is required ONLY for the award as a whole, not for the individual projects.
- c. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200] "Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part [subpart 205]. ## **8. Project/Award Close-Out**

- c. Acknowledgement of support: For all construction projects, the Award recipient shall display a sign that acknowledges the Government's support for the project(s) developed under this Award. The Commission will provide an appropriate sign. The

Award recipient must request an indoor and/or an outdoor sign from the Commission office. Pickup or delivery of the sign can be arranged at that time.

- d. Acknowledgement of support: For all non-construction projects, the Award recipient shall include an acknowledgement of the Government's support for the project(s) developed under this Award. The format for acknowledgement of the Government's support for non-construction awards will vary with each award and must be agreed upon between the Award recipient and the Denali Commission Program Manager. Costs associated with this requirement shall be paid out of the project funding received by the Award recipient from the Denali Commission.

### ***9. Public Policy Laws and Assurances***

Award Recipients are required to comply with the public policy laws and assurances on Standard Forms SF 424b (non-construction projects) or SF 424d (construction projects). No portion of this award may be used for lobbying or propaganda purposes as prohibited by 18 U.S.C. Section 1913 or Section 607(a) of Public Law 96-74.

Project level environmental reviews in accordance with the National Environmental Policy Act (NEPA) and the National Historic Preservation Act (NHPA) are required for each project undertaken with Denali Commission funds.

### ***10. Non-Compliance with Award Conditions***

Recipients not in compliance with the terms and conditions of this Financial Assistance Award will be notified by the Denali Commission. The Denali Commission will work with the recipient to identify the steps necessary to bring them back into compliance, and will establish an appropriate time frame for the corrections to be made. If the corrections have not been made by the deadline, the Denali Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
