*Award Conditions to the Financial Assistance Award
Between the Denali Commission and Southeast Conference

Award No. 156-05*

1. *Scope of Work*

Southeast Conference will develop a legal entity framework for communities, boroughs, and municipalities to collaboratively manage solid waste under the umbrella of a single organization. Models to be examined and evaluated include “cooperatives”, “authorities”, and “federations”. Alaska statutes will be examined to determine if statutory change is required to establish regional management entities. If needed, legislation will be drafted through collaboration with legislators and state agencies. Final documents will include a template for entity formation that can be used in Southeast Alaska as well as other regions of Alaska. This grant is Phase II of a grant funded by USDA RD and currently underway.

All Commission funding is intended for use for the scope of work identified in the Award document only. In the event there is a balance of funding remaining after the full scope of work has been completed, the Denali Commission shall determine how the excess funds will be allocated.

2. *Milestones*

The following milestones are identified as the major steps to be completed as part of the project. “Planned” dates for the first milestone are included here. As part of each progress report, recipients shall update the progress toward meeting these milestones (see section 7, Reporting).

Initiate research:	by February 1, 2005
Complete fund withdrawal:	by September 30, 2005
Submit documents and final reports:	by December 31, 2005

3. *Award Performance Period*

The Award performance period is February 1, 2005 through September 30, 2005. This is the period during which Award recipients can incur obligations or costs against this Award.

4. *Direct and Indirect Costs*

The cost principles of OMB A-122 are applicable to this Award. There are no indirect costs allowable under this Award. Please refer to the cost principles regulations for specific details on other allowable charges under this Award.

5. *Budget and Program Revisions*

The Administrative Circular A-110 applies to this Award. Please refer to the Administrative Circular for specific details on revisions to this Award. The Administrative Circular requires that Southeast Conference will inform the Commission

in writing (e-mail, letter, or report) at the earliest possible date of any unanticipated project cost overrun, project schedule delays, or changes in the project scope or changed site conditions.

6. Payments

Payments under this Award will be made through the U.S. Department of Treasury's Automated Standard Application for Payment (ASAP) system. The ASAP system is the Commission's mechanism for requesting and delivering Federal funds to Award recipients. Southeast Conference must be registered with the ASAP program in order to make draw downs. Payments shall be made in accordance with A-110. **No interest will be accrued on these funds.**

7. Reporting

Two forms of project reporting are required under this Award, listed below. Southeast Conference shall submit reports using the Denali Commission's on-line Project Database System, available at www.denali.gov. If there are technical limitations which may prevent the recipient from meeting this requirement, please contact the Program Manager listed in this agreement.

- a. **Progress Reports** shall be submitted on a quarterly basis. The first reporting period is from January 1 to March 31, 2005, and each quarter thereafter. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
 - i. Total project funding, including both Denali Commission funding and other project funding sources.
 - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and Other funding sources.
 - iii. Update schedule and milestone information as identified in the Scope of Work
 - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
- b. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200] "Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part. [subpart 205] The determination of when an award is expended should be based on when the activity related to the award occurs."

8. Project Close-Out

If the corrections

have not been made by the deadline, the Denali Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
