

1. Scope of Work

The Denali Commission is providing a total of \$3,500 to the National Rural Health Association for the sponsorship of the 31st Annual Rural Health Conference to be held at New Orleans, Louisiana May 7 – May 9, 2008.

The conference expects approximately 1,000 attendees including rural health practitioners, hospital administrators, clinic directors and health lay workers, social workers, state and federal health employees, academics, community members, and others interested in rural healthcare.

This event offers continuing medical education to rural, frontier and tribal health practitioners around the country. The conference will directly affect the ability of rural, frontier, and tribal health practitioners to deliver care to their communities.

This conference will improve the ability of Alaskan practitioners to offer necessary primary care to geographically marginalized communities and maintain the fragile health care deliver systems endemic to the rural, frontier, and tribal communities in Alaska.

Denali Commission funds of \$3,500 for the Conference will provide some of the following:

- Sponsorship recognition in conference publications and website
- Sponsorship recognition on conference signage
- Reserved premium booth space (cost of exhibiting not included)
- Recognition as an NRHA Supporting Member in exhibit directory
- Opportunities to network with NRHA members
- List of conference attendees with contact information

Commission funds for sponsorship can be used for: event space and equipment rentals for the actual event, event costs including video, audio and sound system rentals/services, travel of conference attendees (travel does not include food costs), event brochure printing or other event media needed for attendees. All activities that involve the work of consultants or contractors must be procured through fair and open procurement processes, in keeping with the Federal Circulars in order to be eligible Commission costs.

Commission funds cannot be used for food or beverage of any kind, gifts, per diem of attendees or wages/salaries. Any questions regarding acceptable uses of funds should be directed to the program manager.

All Commission funding is intended for use for the scope of work identified in the Award document only. Any balance of funds remaining after the full scope of work has been completed will be returned to the Denali Commission.

2. Milestones

3. Award Performance Period

The Award performance period is April 1, 2008 through December 31, 2008. This is the period during which Award recipients can incur obligations or costs against this Award.

7. *Project/Award Close-Out*

The project close-out report shall be completed within 90 days of the end of the Award performance period or within 90 days of the completion of the project, whichever is earlier. Recipients must also draw down any remaining funds for expenditures incurred under this award during this 90-day period.

The project close-out report shall be submitted on-line through the Denali Commission's on-line Project Database System, available at www.denali.gov. The project close out will require the recipient to submit the following information:

- a. Final project expenditures itemized by the following categories: planning & design; materials & equipment; freight; labor; project administration/overhead and other expenses.
- b. Acknowledgement of support: For all non-construction projects, the Award recipient shall include an acknowledgement of the Government's support for the project(s) developed under this Award. The format for acknowledgement of the Government's support for non-construction awards will vary with each award and must be agreed upon between the Award recipient and the Denali Commission Project Manager. Acknowledgements are specified in the scope of work above. Costs associated with this requirement shall be paid out of the project funding received by the Award recipient from the Denali Commission.

8. *Public Policy Laws and Assurances*

Award Recipients are required to comply with the public policy laws and assurances on Standard Forms SF 424b (non-construction projects). This form must also be signed by a certifying official of the organization. Some of the laws are highlighted below for your reference.

The Denali Commission will work with the recipient to identify the steps necessary to bring them back into compliance, and will establish an appropriate time frame for the corrections to be made. If the corrections have not been made by the deadline, the Denali Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
