1. Scope of Work

This project provides for transition assistance to A-DHSS, Division of Behavioral Health (DBH) grantees for training on database use and to assist grantees in data input for a portion of active clients into AKAIMS, the behavioral health web-based, MIS software. By having a high percentage of active clients in the system, this will ensure that grantees will begin to utilize AKAIMS for client management, and ensure a speedy transition from paper client files to web-based electronic client files.

The project will be in two phases, of which the Commission funding will be directed as a match to the second phase. Phase one will be funded by the Trust for training assistance and some data inputting will be provided by training team(s) that will travel to grantees during FY05 in the amount of \$100,000. The second component will be managed by A-DHSS DBH with funding to grantees to hire local persons to provide training & data inputting assistance. This \$200,000 component will be funded by \$100,000 from DHSS DBH Co-occurring Disorders State Incentive Grant (CO-SIG) matched by \$100,000 from the Denali Commission.

The A-DHSS, facilities section has an existing grant administration relationship with the Denali Commission and will oversee this project. All Commission funding is intended for use for the scope of work identified in this Award document only. In the event there is a balance of funding remaining after the full scope of work has been completed, the Denali Commission shall determine how the excess funds will be allocated.

2. Milestones

The following milestones are identified as the major steps to be completed as part of the project. "Planned" dates for the first milestone are included here. As part of each progress report, recipients shall update the progress toward meeting these milestones (see section 7, Reporting).

3. Award Performance Period

The Award performance period is March 21, 2005 through February 28, 2006. This is the period during which Award recipients can incur obligations or costs against this Award.

4. Direct and Indirect Costs

No indirect costs are allowable under this award.

5. Budget and Program Revisions

7. Reporting

- a. **Progress Reports** shall be submitted on a quarterly basis. The first reporting period is March 21, 2005 through June 30, 2005, with the first report due July 30, 2005. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
 - i. Total project funding, including both Denali Commission funding and other project funding sources.
 - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and Other funding sources.

- iii. Update schedule and milestone information as identified in the Scope of Work
 - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
 - v. For non-construction projects, pictures should be provided of photos that are representative of the funded activity, to the extent possible. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
- b. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200], “Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part. 8. Project Close-Out

- c. Acknowledgement of support: For all non-construction projects, the Award recipient shall include an acknowledgement of the Government's support for the project(s) developed under this Award. The format for acknowledgement of the Government's support for non-construction awards will vary with each award and must be agreed upon between the Award recipient and the Denali Commission Project Manager. Costs associated with this requirement shall be paid out of the project funding received by the Award recipient from the Denali Commission.

9. Public Policy Laws and Assurances

If the corrections have not been made by the deadline, the Denali Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
