***Award Conditions to the Financial Assistance Award
Between the Denali Commission and Chugach Electric Association, Inc.
For Hope Line Relocation Study
Project No. 0121-DC-2004-19***

1. Scope of Work

Chugach Electric provides retail service to the community of Hope and nearby areas. From the Seward Highway near the Hope Turn-off an overhead 14.4 kV, single-phase distribution line extends 18 miles to Hope. In addition, the tap lines and the Hope area distribution system make up about 26 linear miles to serve 184 metered locations.

The electrical line to Hope has endured numerous prolonged outages due to high winds, falling trees, snow loading, and occasional avalanches. Much of the power line is located well away from the highway and has limited access points combined with rough terrain making sections difficult to access for repairs. Even with the use of helicopters, snowmobiles, or 4-wheelers access may not be possible for long periods of time due to the weather and the terrain situations.

Chugach believes relocating, rebuilding and/or undergrounding sections of this line would shorten outages and reduce repair costs when outages do occur. But Chugach is unlikely to fund relocation or undergrounding based on the revenue derived from the area. This project will study the engineering and economic feasibility issues associated with relocating sections of this line.

All Commission funding is intended for use for the scope of work identified in the Award document only. In the event there is a balance of funding remaining after the full scope of work has been completed, the Denali Commission shall determine how the excess funds will be allocated.

2. Milestones

The following milestones are identified as the major steps to be completed as part of the project. "Planned" dates for the first milestone are included here. As part of each progress report, recipients shall update the progress toward meeting these milestones (see section 7, Reporting).

3. Award Performance Period

The Award performance period is January 1, 2004 through June 30, 2005. This is the period during which Award recipients can incur obligations or costs against this Award.

4. Direct and Indirect Costs

7. Reporting

Two forms of project reporting are required under this Award, listed below. If there are technical limitations which may prevent the recipient from meeting this requirement, please contact the Program Manager listed in this agreement.

- a. **Progress Reports** shall be submitted on quarterly basis. The first reporting period is January 1, 2004 through March 30, 2004, and each quarter thereafter. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
 - i. Total project funding, including both Denali Commission funding and other project funding sources.
 - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and Other funding sources.
 - iii. Update schedule and milestone information as identified in the Scope of Work
 - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
 - v. For minor repair and renovation projects or other non-construction projects, pictures should be provided of before and after, or photos that are

representative of the funded activity, to the extent possible. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.

- b. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200] “Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part. Costs associated with this requirement shall be paid out of the project funding received by the Award recipient from the Denali Commission.
