

1. *Scope of Work*

The intent of this award is to provide financial awards to communities through the State of Alaska Department of Commerce, Community & Economic Development (Department of Commerce) for the purpose of construction of multi-use facilities identified and approved through a Multi-Use Facility Request for Proposal (RFP) process, and as jointly agreed to between Department of Commerce and the Denali Commission Program Manager via e-mail or other form of written documentation. Department of Commerce is responsible for managing all aspects of multi-use facility projects funded by the Denali Commission, but is not required to provide any matching funds to receive this financial award. All matching funds will be provided by recipient communities. Department of Commerce is authorized up to 4% overhead under this award for the program management related to the RFP process and management of projects subsequently funded.

Total Denali Commission funding provided through this award is \$4,712,000. This financial assistance award to Department of Commerce is contingent upon specific project match requirements for new construction funding and repair & renovation funding of recipient communities (see below).

1. Recipient communities must demonstrate that its required match is expended or dedicated to the project prior to any reimbursement by Department of Commerce.
2. Recipient communities must also demonstrate that funding to complete the project is secured prior to any reimbursement by Department of Commerce for its expenses.

All Commission funding is intended for use for the scope of work identified in the Award document only. Any balance of funds remaining after the full scope of work has been completed will be returned to the Denali Commission.

2. Milestones

The following default milestones are identified as the major steps to be completed as part of the construction and repair/renovation projects. Planning and Design projects would use other appropriate milestones. As part of each progress report, recipients shall update the progress toward meeting these milestones (see section 7, Reporting).

3. Award Performance Period

The Award performance period is January 31, 2005 through December 31, 2007. This is the period during which Award recipients can incur obligations or costs against this Award.

4. Direct and Indirect Costs

The cost principles of OMB Circular A-87 apply to this Award. Indirect costs up to 4% are allowable out of this Award for the Department of Commerce. Please refer to the cost principles regulations for specific details on other allowable charges under this Award.

5. Budget and Program Revisions

The Administrative Circular requires that Department of Commerce will inform the Commission in writing (e-mail, letter, or report) at the earliest possible date of any unanticipated project cost overrun, project schedule delays, or changes in the project scope or changed site conditions.

6. Payments

Payments under this Award will be made through the U.S. Department of Treasury's Automated Standard Application for Payment (ASAP) system. The ASAP system is the Commission's mechanism for requesting and delivering Federal funds to Award recipients. Your organization must be registered with the ASAP program in order to make draw downs. Please contact the Commission's Finance Manager at (907)-271-1414 for further information about registering with the ASAP program. Payments shall be made in accordance with OMB Circular A-102. **No interest will be accrued on these funds.**

7. *Reporting*

Three forms of project reporting are required under this Award, listed below. Department of Commerce shall submit reports using the Denali Commission's on-line Project Database System, available at www.denali.gov. If there are technical limitations which prevent the recipient from meeting this requirement, please contact the Program Manager listed in this agreement.

- a. **Progress Reports** shall be submitted on a quarterly basis. The first reporting period is January 1, 2005 – March 30, 2005, and quarterly thereafter. Reports are due within 30 days of the end of the reporting period. Progress reports shall include the following:
 - i. Total project funding, including both Denali Commission funding and other project funding sources.
 - ii. The total project expenditures for the project as of the end of the reporting period, including both Denali Commission and other funding sources.
 - iii. Update schedule and milestone information as identified in the Scope of Work
 - iv. Narrative summary of the project status and accomplishments to date, and address the following questions: is the project on schedule, is the project on budget, and what actions are planned to address any project problems.
 - v. **Construction Projects:** Department of Commerce shall strongly encourage the sub-recipient grantees (community entities) to provide photographic documentation of project progress with the progress reports for active construction projects. The photo documentation shall include a minimum of three, dated photos per reporting period such that a complete record of the construction is maintained over time, from “before,” showing the situation before the start of construction, to “during” showing work proceeding on the project, and “after” to show the finished project. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
 - vi. **Non-Construction Projects:** For minor repair and renovation projects or other non-construction projects, Department of Commerce will strongly encourage the sub-recipient grantees (community entities) to provide pictures of before and after, or photos that are representative of the funded activity, to the extent possible. Photos shall be provided in a digital format as part of the on-line report. A short description of the activity and names of those in the photos shall also be provided.
- b. **Wage and Residency Reports** shall be submitted on an annual basis using the Denali Commission On-line Project Database. The reporting period is January 1st – December 31st of each year. Reports are due within 30 days of the end of the reporting period. The Wage and Residency Report shall include the following information by for each construction project

- i. Total number of Local Residents employed during the year, and their total payroll earnings.
 - ii. Total number of Non-Local Alaska Residents employed during the year, and their total payroll earnings.
 - iii. Total number of Non-Alaska Residents employed during the year, and their total payroll earnings.
- c. **Federal Single Audits** shall be submitted annually, when required. In accordance with OMB Circular A-133, which requires [subpart 200] “Non-Federal entities that expend \$500,000 or more in a year in Federal awards shall have a single or program-specific audit conducted for that year in accordance with the provisions of this part [subpart 205]. The determination of when an award is expended should be based on when the activity related to the award occurs.”

Sub-recipients of this award are subject to the same federal single audit requirements as stated above.

8. Award Close-Out

The award close-out shall be completed within 90 days of the end of the Award performance period or within 90 days of the completion of the project, whichever is earlier. Recipients must also draw down any remaining funds for expenditures incurred under this award during this 90-day period.

The Award Close-out report shall be submitted on-line through the Denali Commission’s on-line Project Database System, available at www.denali.gov. The project close out will require the recipient to submit the following information:

- a. Final data for each item listed in paragraph 7(a) “Progress Reports”
- b. Final project expenditures itemized by the following categories: planning & design; materials & equipment; freight; labor; project administration/overhead and other expenses.
- c. Acknowledgement of support: For all construction projects (including repair and renovation), the Award recipient shall display a sign that acknowledges the Government’s support for the project(s) developed under this Award. The Commission will provide an appropriate sign. The Award recipient must request an indoor and/or an outdoor sign from the Commission office. Pickup or delivery of the sign can be arranged at that time.

- d. Acknowledgement of support: For all non-construction projects, the Award recipient shall include an acknowledgement of the Government's support for the project(s) developed under this Award. The format for acknowledgement of the Government's support for non-construction awards will vary with each award and must be agreed upon between the Award recipient and the Denali Commission Program Manager. For conceptual plans and designs, the sub-recipient shall include the Denali Commission logo and the following statement on the front cover of the document: "Produced with funding from the Denali Commission". Costs associated with this requirement shall be paid out of the project funding received by the Award recipient from the Denali Commission.
