Finding grants in general

Specific grant programs:

- **Brownfields:** existing facilities where redevelopment is complicated by real or perceived contamination.
- **Community Action for a Renewed Environment (CARE):** provides funding to build broad-based partnerships to reduce environmental risks at the local level.
- **Environmental education:** projects to help the public make informed decisions that affect environmental quality.
- **Environmental Information Exchange Network:** provides funding to develop an Internet--based, secure network that supports the electronic collection, exchange, and integration of high-quality data.
- **Environmental Justice:** includes the EJ Community/ University Partnership Grants Program and the Environmental Justice Through Pollution Prevention Grants Program.
- **Fellowships and other student programs:** Grants, fellowships, and research associateships
- **National Clean Diesel Campaign:** building diesel engine emission reduction programs across the country to improve air quality and protect public health..
- **Pollution Prevention:** provides matching funds to state and tribal programs to support pollution prevention and to develop State-based programs.
- **State Innovation Grant Program:** provides funds and technical assistance to state environmental agencies to promote testing of innovative approaches in environmental permitting for better results and efficiency.
- **Science to Achieve Results (STAR):** funds research grants in numerous environmental science and engineering disciplines through a competitive solicitation process and independent peer review.
- **Small Business Innovation Research (SBIR):** competitively funds environmental technology research at small businesses.
- **Water Grants:** includes the state revolving funds for drinking water and wastewater, grants for water pollution prevention and wetlands protection, and tribal grants.

- **Drinking Water State Revolving Fund \$2B National**
 - Drinking Water Infrastructure
- **Brownfields \$100M Nationally for Competitive Grants**
 - Evaluate & Clean Up former Industrial & Commercial Sites
- **Diesel Emissions Reduction \$300M Nationally – Grants & Loans**
 - Projects that Reduce Diesel Emissions
- **Leaking Underground Storage Tanks \$200M Nationally**
 - Cleanup of Petroleum Leaks from Underground Storage Tanks for which there is no identifiable responsible party
- **Superfund Hazardous Waste Cleanup \$600M Nationally**
 - Cleanup of Hazardous Waste Sites – on NPL & construction ready

Clean Water and Drinking Water State Revolving Funds

The American Recovery and Reinvestment Act of 2009 will provide significant levels of funding for states to finance high priority infrastructure projects needed to ensure clean water and safe drinking water. The Clean Water State Revolving Fund program, in place since 1987, will receive \$4 billion. The Drinking Water State Revolving Fund program, in place since 1997, will receive \$2 billion. Together, the Clean Water and Drinking Water State Revolving Fund programs have funded more than 30,000 projects totaling \$84 billion.

- Although SRF assistance is typically in the form of a low interest loan, ARRA requires that **a minimum of 50% of the state grant be used to provide additional subsidization** on assistance in the form of forgiveness of loan principal, negative interest rate loans, or grants.
- 604b Water Quality Management Planning CWA 205(J) \$=1% of SRF State is to pass through 40% of its funds to local, regional or interstate comprehensive planning organizations, or if there are strong reasons for waiving this, the Governor may approve a waiver. The American Recovery and Reinvestment Act of 2009 will provide \$100 million to the [EPA Brownfields Program](#) for clean up, revitalization, and sustainable reuse of contaminated properties. The funds will be awarded to eligible entities through job training, assessment, revolving loan fund, and cleanup grants.
