AGREEMENT INFO: Tununak Community Streets Reconstruction

The purpose of this amendment is to provide an additional \$98,588.13 in FY10 FHWA funds and \$3,464.38 in State of Alaska General Funds. RA-531 (Tununak Community Streets Design) has been closed out and the remaining funds are provided to this award for the same scope of work.

This amendment also changes the title of the award from Tununak Community Streets Reconstruction to Tununak Community Streets Design and Reconstruction, and allows for WFLHD to bill as needed rather than quarterly as stated in section II.C of the original grant agreement
