A Message from Federal Co-Chair *George Cannelos*

Dear Friends of the Denali Commission,

Ten years ago this October, the Denali Commission Act was signed into law. Our creation involved the support of Congress and many others who had the vision to create something unique in American government. The Denali Commission model does not



simply provide assistance for the development of rural infrastructure; the Commission model requires involvement from community leadership in which it serves, promoting self-governance, sustainability and requiring a vested interest in every project conceived.

It was our goal ten years ago, to work ourselves out of a job. That is still our goal today; and someday, I hope to report to Congress: **The Job is Done!** But unfortunately, we are not there yet – in fact, we have huge challenges before us.

To date, the Commission has completed 96 bulk fuel projects and 45 new tank farms are in progress. These tanks represent the cornerstone of our rural communities and their replacement was the initial purpose of our creation. Rural power system upgrades have improved efficiencies in 43 different communities and 23 are currently in progress. And finally, the energy program has had 76 "other" projects completed. These *other* projects are probably some of the most important as they hold the key to rural Alaska's future. Other projects include wind turbines, intertie's, and alternative-renewable energy projects — a solution that will supplement existing

Our second "legacy program" – health – began its work in 2001 and focuses on primary care facilities across the state of which roughly 300 communities were identified initially as having some level of infrastructure need. Our focus now includes a "mix of other health and social service related facilities". The Commission has funded 111 primary care clinics with another 40 or so projects in design. Elder housing/assisted living and domestic violence shelters have been part of this plan and across the state, we are seeing access to state of the art healthcare facilities.

Congress passed the SAFETEA-LU law in 2005 creating the Denali Commission's Transportation Program. To date, we have funded 115 projects that include road improvements, barge mooring, boardwalks (the lifeline in many rural communities) and even dust control projects.

Our training program has reached over 6,000 individuals in various types of training, and our Economic Development program has had over 130 projects over the years. Solid waste and teacher housing are two examples of smaller program areas, but they represent the diversified need that exists in rural Alaska; basic needs, that for many in the lower 48 states, are met without question. Not so for rural Alaska.

Looking back over the past ten years the Denali Commission has maintained a small staff and kept costs down, always adhering to the spirit and intent of our legislation which requires us to keep administrative costs below 5%. We could not accomplish our mission without the close support, hard work and dedication of partner organizations to meet the needs of rural Alaska. They include state, private, Native, and other federal agencies. These partnerships continue to be a vital component of our success and our program delivery. I extend my sincere appreciation and thanks on behalf of our Commissioners and staff to our wonderful partners who help us make this all happen day in and day out.

In closing I would ask you to mark your calendars February 2 – 6, 2009 for the next Alaska Forum on the Environment in Anchorage. We'll look back at the
